Today, over \$4.5 million in donations to MBEF are embedded in a child's school day, keeping class sizes small, music programs thriving, libraries and guidance centers staffed, and our children learning at an exceptional level.

## An MBEF Primer

Imagine your school system without MBEF. Considering that MBEF's grants are almost ten percent of the school district's budget, and that the educators we fund are enough to staff an entire elementary school, it's not a pleasant thought. Our classrooms would be overcrowded, there would be furlough days and no enrichment. These wouldn't be the schools that entice families to move to Manhattan Beach.

MBEF is an independent non-profit run by a volunteer board of 33 parents, including PTA presidents. We raise money from parents and the community (but mostly parents) and we grant this money to our school district to pay for teachers and staff in our seven schools. MBEF is the only parent organization that can pay for teachers, which is why our schools have MBEF and PTAs. MBEF pays for staff, PTA pays for stuff. We support one another. This year MBEF funded 66 educators, most of whom are classroom teachers. Others are teachers for enrichment (such as music, science labs, reading, writing, computers), counselors and librarians. The total cost for these educators is \$4.6 million.


MBEF's board makes decisions about where our money is allocated while working alongside the school board, administration and teachers. We raise money a year in advance so that we know by springtime, when the school district's budget is made, how much money we have for the following school year.

You see, California isn't like other states that allow counties and townships to set property taxes to fund the kind of schools residents want. California's Prop 13 reduced property taxes but it also effectively took away a school district's ability to tax its community for schools. A 1976 state Supreme Court ruling aimed at eliminating funding disparity between wealthy and poor school districts resulted in laws that allowed the state to establish school funding levels. Today our schools are largely funded by income and business taxes, not property taxes. Thus, regardless of the amount of property tax you pay in Manhattan Beach, schools are funded roughly the same here as elsewhere in the state, and that funding level will fluctuate somewhat with the state's revenue. Today California ranks 45th in the nation in per-pupil spending.

MBEF provides a means to stabilize this inherently unstable school funding system and to give students the fundamentals of a well-rounded, quality education.

When MBEF was founded in 1983, parents couldn't have foreseen economic catastrophe 25 years later, but they were wise enough to create the organization that could handle it. In 1990 they started a small savings fund, too, and today the MBEF Endowment is a \$7-million fund on its way to a \$10-million goal and a source of perpetual funding.

It's a tribute to our students and teachers that in spite of challenges, our schools rank with the best in the state, and in many cases, the nation. And it's a tribute to the parents in our community that we've worked together to help our children every step of the way.



## **Our Financial Performance**


MBEF is playing a greater role in school funding than at any time in our twenty-eight year history. As state resources shrink, our contribution to our schools grows. It is clear to us that local revenue, and the local control it allows, will be critical to the future success of our students and our schools.

MBEF raises money in one school year to fund grants for the following school year. Funds raised in 2010-2011 are paying for teachers in the 2011-2012 school year. We estimate our grants in advance but do not pay them until we receive an accounting of the actual cost of the grant. We pay the lesser of the estimated or actual cost.

## Our Endowment

The MBEF Endowment has been in existence since 1990 when the MBEF board put aside \$10,000 in savings. In 2005, a formal investment committee was created to invest and manage assets that had accumulated through various fundraisers. Today the Endowment's assets are over \$7 million, the result of a few recent large gifts, a portion of the proceeds from many Manhattan Wine Auctions, and return on investment. At least one-third of Wine Auction proceeds goes to the Endowment each year as stipulated in our bylaws. The fund is well managed by our Investment Committee, and the assets are held in a diversified portfolio that has outperformed relevant benchmarks.

We are in the midst of a quiet campaign seeking large gifts. In 2010-2011 we received our first leadership gift of \$250,000 from current parents Ellen and Mike Rosenberg and a \$50,000 gift from Peggy and Peter Johnston, parents of an alumnus. And in FY2012 we have already received a \$250,000 gift from Joan and Brad Jones and a \$100,000 pledge from Jan and Chet Pipkin. Also, Plaza El Segundo continues to make payments on its \$1 million pledge to MBEF made in 2005. Finally, we are creating a subsidiary 501(c)(3) corporation for the Endowment with a separate board of directors to support the needs of a capital campaign. We are on our way.



MBEF is not the only public school system to have an endowment but we are one of the few that has such a high goal for its funding. Many ed foundations opt to use the return on investment from their endowment funds right away. We have opted for a longer-term, longer-lasting approach. Our minimum funding goal is \$10 million. When we reach that goal, we can begin to use a portion of the return on investment to help fund annual MBEF grants. With our current campaign, we hope to reach our \$10-million goal relatively soon. And after that, the sky's the limit. We dream of an endowment fund that grows to meet all our funding needs.

"In a tumultuous year, our portfolio has weathered the storm well. Due to significant contributions, the portfolio's total value now exceeds \$7 million. Inception to date, the portfolio has an annual return over 6.1%. This is an excellent performance record relative to virtually any other investment benchmark over this same period and continues to help us fulfill our goal of supporting our community, our schools, and our children."

Held every June, the event features food donated by 35 of the finest local restaurants and wine from 80 world class vintners. Proceeds topped \$740,000 this year, a portion of which was allocated to the MBEF Endowment.
